

The Gutter Cover Company Warranty*

The Gutter Cover products come with a **baked on enamel finish coating** that is warranted not to crack, chip or peel and will resist fading chalking and the effects of corrosive air pollution for a period of Twenty (20) years. **This Limited Warranty is fully transferable to subsequent owners** of the home or building without fee, subject to the inspection, certification, exceptions, and terms and conditions contained in these warranties.

Limited Installation Warranty The Gutter Cover Company warrants the installation of the Gutter Cover system for Lifetime. Any problems resulting from the installation of The Gutter Cover system will be corrected by the Gutter Cover Company at no charge, subject to the exclusions listed below. Any damage that is caused by hail, falling tree branches, animals, ladders being placed against **The Gutter Cover Company** panels, or other unusual acts, will also result in a service charge to repair or replace.

Although **The Gutter Cover Company** system can handle very heavy rainfall, sometimes a guttering system may not be able to handle a sudden downpour and some run over will occur temporarily. Installation of **The Gutter Cover Company** system will not increase the capacity of your existing gutters, but **The Gutter Cover Company** panel system will maximize the functional water flow capacity of your existing guttering and downspout system.

Painting the specially coated The Gutter Cover product will VOID this warranty.

Roof maintenance, repair or replacement without first calling the Gutter Cover Company will VOID this warranty. If an unauthorized person works on The Gutter Cover, per performance warranty becomes null and void.

The formation of icicles is not a warranted defect and in fact is an indication that The Gutter Cover system is working properly, keeping ice out of your gutters. Future performance will not be affected.

The Gutter Cover Company does not warrant the performance of any underground drainage systems. Any problems related to such a system are not related to The Gutter Cover system and Purchaser specifically waives any claims against The Gutter Cover Company arising out of any failure in the underground drainage system. In instances where the design of the building results in valleys in the roofs that result in the accumulation of debris which may cause the diversion of water to an area not intended or designed by The Gutter Cover Company or the builder of the structure, this Warranty shall not extend to the removal of the debris.

Lifetime No-Clog Performance Warranty The Gutter Cover Company warrants to the original purchaser of The Gutter Cover products covered by this performance warranty, that The Gutter Cover products will keep the gutters clean and water flowing freely in the gutters, subject to the exceptions, limitations, disclaimers and other terms and conditions contained in these Warranties. Upon the unlikely occurrence of clogging or blockage, **The Gutter Cover Company will remove any debris that naturally enters into the gutter and causes the clogging or blockage at no charge for the LIFETIME of the Gutter Cover Company system on the building.**
